#### SECTION D: TECHNICAL DATA

# 1. Scope of Work

The African Court on Human and Peoples' Rights [the Court] would like to procure a Power Generator for the Residence of the Registrar located in Arusha, Tanzania.

#### 2. Features

#### **Standby Rating:**

22 kVA with output available with variable load for the duration of the interruption. Water cooled, Diesel Engine.

#### **Prime Rating:**

Output available with varying load for an unlimited time. Average power output is 70% of the prime power rating.

#### **Power Generator and Enclosure Features**

- 1. 22 kVA with 3 phase power specification.
- 2. Automatic Transfer Switch (63Amp / 3 Phase).
- 3. Engine Specifications; Diesel fuel, 4 Cylinder vertical in line, water-cooled, with Perkins, Caterpillar (Olympian) or Cummins engine.
- 4. Control Panel with event logs for running Hrs, Alarms and events.
- 5. Weatherproof enclosure with internally mounted exhaust silencer.
- 6. Sound Attenuated Level 2 Enclosure.
- 7. Sound Pressure levels (dBA) certified to have sound levels ranging between 60.0 70.0 (50Hz) at 7metres and 65.0 70.0 (60Hz) at 7 Metres.

- 8. Should have an extremely robust enclosure designed to resist corrosion and handling.
- 9. Lockable enclosure doors with viewing window for the Control Panel.
- 10. 12V Static Battery Charger.
- 11. Emergency stop button mounted on exterior.
- 12. Cooling fan and battery charging alternator fully guarded.
- 13. Fuel fill and battery should only be reached via the lockable access doors.
- 14. Side Hinged doors on both sides.
- 15. Removable front and rear panels.

Experience of at least three years providing similar generators and maintenance services.

Should provide service and maintenance plans and requirements for the generator.

A dealer certification or authorisation to sell and maintain the power generators should be provided.

#### Warranty:

The Power generator should have a manufacturer's warranty of a minimum of 12 months from the date of delivery.

The bidders can propose different models for the same item.
