I, the above mentioned applicant beg to this Honourable Court of Justice Human and people's rights to grant and allow me to lodge memorandum of complaints of violation of Human rights and justice on the for the following reason inter-alia;-

- 1. That, the applicant was convicted and sentenced to serve thirty (30) years in jail with corporal punishment the sentence which violating articles 13 (6),(d) (e) of the Constitution of the United Republic of Tanzania 1977 special right.
- 2. That, according to the copy of judgment the court of appeal had not considered the omission appeal in the charged sheet as the court considered the other cases like this, this circumstance shows that the Court violated articles 13 (1) (2) of the constitution of the United Republic of Tanzania of 1977 it was violating the fundamental right of being equal before the law and being heard before the court of law as required by article 3 (2) of the charter of the court.
- 3. That, the prosecution side have representation while the applicant he was no legal representative his right to be heard were deprived. This position has violated the fundamental rights of the Court contrary to article 10 (2) of the protocol to the charter.
- **4.** That, the applicant humbly prays that this Honourable Court to restore the justice where it was overlooked and quash the conviction and the meted sentence and set him free from custody.

- 5. That, the Court may grant any other legal remedy that the court may think fit and just to grant in the circumstance of the complaint.
- **6.** That, the applicant intended to be supported by a submission of the complaints of violation of Human rights and justice accompanied with the copy of judgment of the court of appeal.
