 - 2. That, the evidence of complainant was received and used before the Court of Law without compliance with section 127 (2) of the law of Evidence Act.Cap.6 R.E 2002. This position violated article 13 (1) and (6) (a) of the Constitution of the United Republic of Tanzania 1977 special right (The mother law).
 - 3. That, the applicant he was denied a fair hearing when the Court disregarding the age of the applicant who was under sixteen (16) age, the sentence of LIFE Imprisonment was unfair at all.

- 4. That, the applicant he was not afforded legal representative, this position violated article 10 (2) of the protocol to the African charter on Human and peoples rights, also violated section 2 of the child and young offenders Act.Cap.13 R.E 2002...
- 5. That, the applicant humbly prays that this Honourable Court to re-store justice where it was overlooked and quash the conviction and sentence of LIFE IN JAIL meted on me and order to my release from the Prison Custody..
