

# Peer to peer meeting with Mallory International

In September the library had peer to peer meeting with the Mallory International team. The Mallory team was comprised of Louis Wenley (Director of Library services) and Mathieu Peligry (Director and account manager, Africa Division). The African Court was represented by the following;

The meeting discussed among others the African Court E-Library project, access to the Baobab e-library platform, streamlining of the supply of books, processing of payments, the Mallory e-book platform and the impending change of personnel at Mallory London office.

is a long-term process. The following developments were reported as of mid-September 2022; a)Subscription to Baobab platform for electronic books under the EU-AGA project was completed and the library now has access to thousands of electronic resources. b)Subscription to Sabinet Journals.





- c) The library is continuing to download relevant e-books and journals as we come across them.
- d) The library has requested the HR training unit to source for training opportunities for E-Library and knowledge management for library staff. It is hoped that this will be conducted before end of year.
- e) EBSCO information services has created an initial E-Library for the Court, with over 2000 free e-books. The library is deeply grateful for the gesture.
- f) The Court taskforce on knowledge management is now at

the stage of collecting data on knowledge status and requirements at the Court. They are interviewing all units and staff at the Court starting with those that at the frontline of knowledge management.

#### **Notable visitors to the Court**

The library received about 100 participants to the Conference of the Africa Chapter of the International Association of Refugee Magistrates and Judges. The conference was held at Arusha from 14–18 November 2022.



The Library also received Mr. Marcel C. Akpovo, the regional representative of the United Nations Office of High Commissioner for Human Rights to the African Union and East Africa in November 2022. They visitors were greatly impressed with the African Court library and the librarian asked them to tell others about it.
